

Omaha Public Schools Middle Level Activities Contract
Lewis and Clark Middle School
'24-'25 School Year

Academic

1. At the start of each season and/or co-curricular activity, students' academic standing will be considered.
2. Grades will be evaluated weekly for all students involved in each sport.
3. If a student is in failing status for a class, the student will be mandated to receive academic intervention/support.
4. If, after the two weeks of failing status and academic improvements have not been made, the student athlete may be dropped from the sport/activity.

Attendance

1. All student participants should be in attendance for the entire school day, on the day of a competition. Any student absent for any portion of the competition day must have contact from a parent/guardian explaining the cause of the absence, so that the absence can be documented correctly within Infinite Campus. If a student is absent for any portion of the day, they may be ineligible to compete.
2. Students who are truant from school, or "skip" a class on the day of a competition, may be ineligible to compete/participate in activities at the discretion of the building administration.

Citizenship/Behavior

1. Student participants assigned to the Student Success Center (S.S.C.) or to Suspension After School (S.A.S)/Late School may be ineligible to practice and/or compete on the date(s) of their SSC/SAS/Late School assignment(s).
2. Cooperation with staff members and the positive representation of Lewis and Clark Middle School is essential. Students may be removed from any level of co-curricular activities if they fail to exhibit acceptable behavior.
3. The following could result in being excused from the team:
 - a. Suspension
 - b. Repeated Violations of the OPS Code of Conduct
 - c. Failing Grades
 - d. Poor team conduct
 - e. Missing practices/competitions

Physical Exam, Insurance Coverage, Parent/Student Consent, Contract, Concussion

1. In order to participate in Middle Level Activities, the following must be submitted PRIOR to the season beginning:
 - a. OPS Middle Schools **Middle Level Activities Contract**
 - b. **Student and Parent Consent Form**
 - c. **Sports physical** completed by a physician **after May 1st 2024**. The OPS provided form can be submitted or documentation from a licensed physician stating that the student is cleared to participate in school competitive sports program(s).
 - d. **Concussion Fact Sheet for Students and Parents**
 - e. **Insurance Coverage form**
