The Board of Trustees of the Omaha School Employees' Retirement System held a Regular Meeting on Thursday, June 8, 2017, at 9:09 a.m. at 1st National Bank, 1601 Dodge Street, Omaha, Nebraska.

Pursuant to Section 84-1411 of the Nebraska Statutes, notice of this meeting was given by announcement by the President of the Board at the Board of Trustees' meeting held on May 3, 2017.

- 4979 –

President Erikson announced that, pursuant to Section 84-1411 of the Nebraska Statutes, the next regular meeting of the Board of Trustees will be held Tuesday, August 1, 2017 at 9:00 a.m., at the Teachers Administrative Center, 3215 Cuming Street, Omaha, Nebraska. The agenda will be kept current and available for public inspection in the Retirement Office at the Teacher Administrative Center during regular working hours. He further announced that pursuant to Section 84-1412 of the Nebraska Statutes, the public is hereby informed that a current copy of the Nebraska Open Meetings Act is posted in the Board of Education meeting room on the north wall.

4980 –

The meeting opened with Ms. Carter introducing Mr. Michael Walden-Newman, the Nebraska State Investment Officer, Mr. Joseph Jurich, the Deputy State Investment Officer, and Mr. Michael Comstock of AON (the Nebraska Investment Council's investment consulting firm) to the Board of Trustees of the OSERS retirement board to discuss the 1st quarter performance of the OSERS portfolio post the January 1, 2017 transition to the Nebraska Investment Council. Mr. Walden-Newman began his remarks with an overview of the transition which occurred from June 2016 through January 2017. He presented to the Board of Trustees the 2016Annual Report Executive Summary and provided a copy of the "Plan to Transition the Management of Retirement Assets from the Omaha School Employees Retirement System ("OSERS") to the Nebraska Investment Council ("The Council") on January 1, 2017.

Mr. Jurich then presented to the Board of Trustees an overview of the bank providing the custodial services – State Street Bank & Trust, along with an overview of the Nebraska Investment Council's decision to liquidate at least ten investment managers from the OSERS transition and further transition those assets into the greater NIC portfolio. A comment was made by the SIO that the OSERS portfolio was more liquid that was anticipated and thus the transition of the terminated managers into the greater NIC portfolio was conducted seamlessly.

Mr. Michael Comstock presented the retirement board with the "OSERS / First Quarter 2017 Quarterly Investment Review." The report indicates the NIC took management authority on January 1, 2017 of \$1,139 billion and experienced withdrawal request of \$18.8 million in the first quarter of 2017; however the portfolio earned \$39.7 million in investment earnings for a March 31, 2017 closing balance of \$,160.7 billion. This represents a performance return of 3.4% return for the first quarter 2017. Mr. Comstock and the board engaged in conversation over the disposition of the other assets transitioned from OSERS to the NIC. Mr. Comstock assured the board there was no desire to jeopardize the integrity of the portfolio by engaging in any *fire sale*.

The retirement board, along with the SIO, Deputy SIO and AON represented continued to engage in discussion on the portfolio and the future disposition of the asset managers.

The board took a ten minute break at 10:30 a.m. as the investment team of Michael Walden-Newman, Joseph Jurich, and Michael Comstock left the meeting.

Mr. Rea moved the OSERS Board of Trustees go into Closed Session. The motion was seconded by Mr. Purdy and adopted by the following roll call vote: Aye: Erikson – Evans - Havlovic – Jones – Purdy – Rea - Ripa. - 7. President Erikson reminded the public the Board went into Closed Session at 10:47 a.m. for the protection of public interest and for the prevention of needless injury to the reputation of individuals to discuss with Cecelia Carter, Executive Director and James Ellis, and OSERS' Legal Counsel, Robert Bothe, McGrath North matters on the Retirement System.

President Erikson reconvened the meeting at 11:00 a.m.

Mr. Rea moved the OSERS Board of Trustees ratify the June 2017 pension payments, ratify the OSERS staff payroll, approve the June 1st new retirements, ratify termination of annuitant payments due to death, approve refunds to former employees, and accounts payables for June.

President Erikson introduced Jack Peetz, Peetz & Company to discuss 2017 legislative matters. Mr. Peetz gave the Board an overview of the legislative session 2017 starting from January through the close of the session on May 23, 2017. Mr. Peetz primary focus of discussion centered on the submission of LB 548 and the submission and passage of LB 415.

- 4984 –

Executive Director's Report

Ms. Carter reviewed the status of the RFP for Audit services. The RFP responses are due June 12, 2017. Upon receipt of responses and review of the responses by the OPS CFO, OPS Accounting Manager, OPS Internal Auditor, and OSERS Executive Director, a recommendation will be made to the OSERS board of trustees. She expects a special board meeting may need to be held during the hiatus depending upon the number of responses.

Ms. Carter provided the Board with the dates for the 2017 / 2018 New Employee Workshops on OSERS. This workshop is coordinated through Human Resources as a career development workshop. It is OSERS opportunity to address the nuances of the plan with new employees, especially new career employees. The dates are as follows: August 15, September 13, November 8, 2017 and January 10 and March 20, 2018. This school year there will be five workshops, all intended to be no more than one hour and held at the Teachers Administrative Center (the TAC building).

Ms. Carter discussed the Membership Education Workshops for retiring members of OSERS. There will be four workshops in the 2017 / 2018 school year. One each quarter. The intent is to hold these workshops in the early evening to ensure spouses and partners can attend and to hold one workshop mid-day on a non-teaching day to accommodate those who cannot attend in the evening.

Ms. Carter referenced a recent Omaha World-Herald newspaper article which reported on the actuarial required contribution of OPS (the pension plan sponsor). There was board discussion on the matter and questions as to why the OPS Board of Education does not discuss with the OSERS Retirement Board it's thoughts, plans, and ideas regarding OSERS.

Mr. Ripa made a motion and Mr. Purdy to accept the Executive Director's Report: Erikson – Evans – Havlovic – Jones – Purdy – Rea – Ripa – 7.

Mr. Rea made a motion and Mr. Ripa seconded the motion to engage the OPS Board of Education to form a working group with the OSERS Board of Trustees and one OSERS staff person to explore all

options to address the unfunded actuarial accrued liability of the OSERS plan. The motion was adopted by the following vote: Erikson – Evans – Havlovic – Jones – Purdy – Rea – Ripa – 7.

The Board took a break from 12:30 p.m. to 1:20 p.m.

Board of Trustees' Report

Mr. Rea reported he is serving on a discussion panel in September for the National Council of Public Employees' Retirement Systems (NCPERS). His panel is discussing pension plan funding options.

Mr. Jones informed the Board of his decision to relocate to Iowa. He was concerned there was a residency requirement to remain on the OSERS board. Ms. Carter informed the board that after research and discussion with legal counsel, OSERS board does not have a residency requirement. Mr. Jones expressed his desire and willingness to remain on the OSERS board of trustees.
