## In General

  - An annual meeting is held the first Wednesday in September in the evening to inform and explain requirements of the Title I program for parents and family members. An invite is sent to all families so that we have translators available if needed at the annual meeting. We also hold events in late fall and late spring, during the school day, to review plan and get input on school improvement. Lothrop Magnet Elementary School has a Family Room Liaison who can meet with families or connect the family with a staff member for a one on one or phone conference.
- Parents and family members are involved in the planning, review and improvement of the Title I program, Parent and Family Engagement Policy and the Parent/Student/School Compact at an Annual Parent Meeting scheduled at a convenient time. This would include the planning and implementation of effective parent and family involvement activities.

School and parents will build and develop a partnership to help children achieve the state's high standards through:

- During the month of May, our principal surveys a sample of third and fourth graders to find out what went well, what we can improve on, their favorite pieces of learning and how it will impact them in the future. We also provide parents and community members a quick survey at our last Family Night to get input on our strengths and suggestions for improvement at Lothrop Magnet Elementary School. Teachers are also given time at the last staff meeting in May to share strengths of the school year, and provide suggestions for improvement for the next school year.
- Conduct, with meaningful parent and family involvement, an annual evaluation of the content and effectiveness of the Parent and Family Engagement Policy. Use the evaluation findings to design evidence-based strategies for more effective parental involvement, and to revise the Parent and Family Engagement Policy.
