Unit Title: Elizabeth Pittman, Legal Pioneer

Concept Based (Enduring Understandings/Generalizations): Pioneers face challenges as they break through barriers. Elizabeth Pittman was a pioneer in the fact that she was the first black female graduate of Creighton Law School and the first female and first black judge in the state of Nebraska.

**Materials & Resources:** Post-it notes (2 per student), copies of the primary sources for the gallery walk, writing utensils, and notebook paper

**Accommodations for Students with IEPs or 504s:** Copies of the charts and peer tutors for the questions and gallery walk

**Literacy Strategies:** Think alouds and summarizing

**Procedures/Routine Focus:** Hand raising and group work

**Anticipatory Set:** Write the word *pioneer* on the board or place the word under a document camera. Give each student two Post-it notes. On one of the Post-it notes, have the students write the name of a pioneer, and on the other Post-it note, have the students write a characteristic of a pioneer. Demonstrate the activity by writing your own person and characteristic using the think-aloud method.

Examples of pioneers: Neil Armstrong, Meriwether Lewis, William Clark, Laura Ingalls Wilder, Rosa Parks

Examples of characteristics: brave, bold, and intelligent

# **Objective/Learning Goals**

I will know (knowledge): a definition of *pioneer* and facts about Elizabeth Davis Pittman.

**I will be able to (skill):** use primary sources to answer an essay question explaining how Elizabeth Davis Pittman was a legal pioneer in Nebraska.

# **Procedures (GRL)**

# Modeled:

1. Lead a discussion of what a pioneer is. ("A pioneer is a person who is the first to do something" is a definition to use for this assignment.)

# **Shared:**

- 2. Have the students set up the Pittman Gallery Walk chart on a piece of paper.
- 3. When the students have it completed, use the map of lawyers in 1950 as partner work as an example. Share out as a class after about 4 minutes of work time.

#### **Guided:**

- 4. The students will now walk around to the stations to complete their charts. They will have 5 minutes at each station. When the students are at their final station, they will stay there and then share out what the primary source is and how it relates to being a pioneer. Take a volunteer to start off the sharing; then, move clockwise to have the students share out.
- 5. The students will now complete the "Pittman as a Pioneer" assignment using the web page found at http://invisiblehistory.ops.org/StudentProjects/2016StudentProjects/JudgeElizabethPittman/tabid/291/Default.as px. The web page can be displayed using the projector, or each partnership of students can use a computer to look at the web page. See the handout for further instructions and information.

# **Independent:**

6. Elizabeth Pittman Essay Question: The students will be asked to write an essay using the following prompt: In what ways was Elizabeth Pittman a pioneer in the legal system of Nebraska? What prejudices and discrimination did she face and have to overcome in order to become a lawyer and later a judge?

# **Summary:**


7. Have a class discussion about examples of how Pittman was a pioneer. Have five students share their ideas.

# Elizabeth D. Pittman Muny Court Judge

Gov. J. J. Exon Friday said he has appointed Deputy County Attorney Elizabeth D. Pittman to the Municipal Court bench.

Exon said he arrived at his décision after interviewing Mrs. Pittman in Lincoln Friday morning.

Mrs. Pittman is the first Negro woman to be admitted to practice law in Nebraska and will be the first black to serve on an Omaha area bench.

Mrs. Pittman, 49, is a graduate of the Creighton University Law School. She was one of three persons recommended to succeed the late Judge Jay Gibbs by the Judicial Nominating Commission. Others were Asst. City Prosecutor John Gutowski and Francis A. Lane.

Mrs. Pittman joined the Douglas County attorney's office in 1964, the first black to do so.

She was elected president of the National Federation of Settlements and Neighborhod Centers last year and has been active in a number of Omaha civic groups.
