- 1.) We have read the Show Choir Auditions handbook and understand all the requirements, expectations, and consequences as listed.
- 2.) We understand that the director's decisions regarding student placement is final, however if questions and/or problems arise we can address them with Mr. Gruttemeyer.
- 3.) We understand that as members of the South High Show Choir program, students will be expected to act with professionalism and respect when representing South and our community (including on social media). We understand a failure to do so may result in removal from the Show Choir program.
- 4.) We understand that if students do not follow through with their obligations to the Show Choir program, that it might mean a removal from the ensemble at semester, and/or probation from upcoming performances.
- 5.) We understand that should a student be removed from the Show Choir program, they may be financially responsible for any purchases made for the 2023-2024 season for the individual student (regarding costuming, travel, etc.). Proof of purchase will be provided should this occur to families.
- 6.) We understand that to be a member of South High Show Choir program, students are **required** to be enrolled in one of South Highs traditional Concert Choirs (Freshman Choir, Mixed Chorus, or Concert Choir).
- 7.) We understand that students will be asked to fundraise a specified amount dependent on the ensemble they make to cover personal belongings that cannot be reused, and/or travel. A fee will be placed on Infinite Campus that families may pay either electronically or through our school treasurer.
- 8.) We understand and allow Mr. Gruttemeyer to look and adjust schedules for the 2023-2024 school year and that we will be contacted should a scheduling concern requiring attention be made in order for a student to participate in the ensemble they have been accepted into.
